**Subject: Land Interest Questionnaire for A46 Newark Bypass Project.**

National Highways is currently developing proposals to improve the A46 at Newark-on-Trent. The project will improve capacity to address traffic congestion on the A46. To inform our ongoing development work, we wish to identify the names and addresses of all owners, lessees and occupiers of property that may be affected by the proposed scheme.

National Highways has appointed Skanska Mott MacDonald to act on their behalf to make enquiries on aspects of land interest information. The construction and operation of the scheme would be authorised by a Development Consent Order (DCO).

We wish to identify the names and addresses of all owners, lessees and occupiers of property who may be affected by the proposed scheme so that we can formally notify you when the DCO is submitted. This information also helps us to consult with you and ensures you have an opportunity to comment on the scheme as the design develops.

We would appreciate a response within 14 days of receipt of this letter. The information you supply will ensure that any interest which you may have in the land is correctly recorded.

Enclosed with this letter is;

- 1) Land Interest Questionnaire (LIQ). The LIQ is provided so you can confirm the information we have received is correct, identify any changes to land ownership / interest and confirm any other interests that others may hold over the land. Once complete please sign the form and return to us so we can contact further land interests you have identified.

- 2) A plan which shows the extent of land that we believe you have an interest in. Please also sign and return the plan to confirm that the boundary is correct. If the boundary is not correct please mark on the plans the required amendments and send them back to us.
- 3) A pre-paid envelope to return the questionnaire and plan
